Directing the clerk to issue the warrants, Judge Rowe commented sharply that he was "satisfied both defendants had made false statements" in their recorders court trial on whiskey charges.

Cockman was convicted of unlawful possession of illicit whiskey for sale and selling, and Hasty pled nolo contendere to unlawful possession and transporting. Each received a 60-day road sentence, suspended on payment of \$50 fine and costs, on testimony by two ABC officers and Deputy Sheriff A. W. Lambert. Cockman's counsel, W. D. Sabiston, gave notice of appeal from the whiskey conviction, and bond of \$200 was made. On account of his nolo contendere plea Hasty had no recourse in appeal. Hasty was represented by H. F. Seawell.

During the trial Hasty repudiated a statement officers said he had made to them when arrested May 2 with a pint of white liquor in his possession. Deputy Lambert and ABC Officer Kieth Marks said he told them he had bought it from Cockman. Justice of the Peace Charles M. 




