

Four From Here To Serve Methodist College Committee

Lynn Ledden, W. A. Leonard, Mrs. Earl Hubbard and Reverend R. L. Bame, pastor, will represent Southern Pines Methodist Church on the special Conference Advisory Committee for the new Methodist College in Fayetteville.

Terry Sanford, of Fayetteville, Chairman of the proposed institution's board of trustees, in announcing the appointments, said: "We expect to rely a great deal upon the advice and help of these and other leaders as we go forward with our college project."

This identity with the college, he said, will confer upon committee members the distinction of "honorary alumni".

The new institution, chartered by the North Carolina Methodist Conference, is scheduled to be erected on a 700-acre site about three miles north of Fayetteville on the Raleigh highway.

Textron Declares Year-End Dividend

The board of directors of Textron Inc. has declared a dividend on the \$1.25 convertible preferred stock of the corporation of thirty-one and one-quarter cents per share and a dividend on the common stock of the corporation of forty cents per share, both such dividends to be payable January 1, 1957 to holders of record at the close of business December 14, 1956.

These dividends will also be payable to holders of preferred stock series "A" and common stock of Robbins Mills, Inc. and to holders of common stock of American Woolen Company who, pursuant to merger agreement, exchanged their shares for Textron Inc. stock on or before January 1, 1957. Holders who do not make such exchange until after January 1, 1957 will receive their dividends at the time of making the exchange.

In addition, the regular quarterly dividend of one dollar per share on the 4 per cent preferred stock series "A" and series "B" of the corporation was declared payable January 1, 1957 to holders of record as of the close of business on December 14, 1956.

Dr. William M. Peck of Raleigh has been elected president of the Southern Trudeau Society, a nation-wide group of physicians specializing in the treatment of tuberculosis.

Dr. Peck, formerly medical director of the North Carolina Sanatorium at McCain, is now a consultant on tuberculosis with the N. C. State Board of Health. While connected with McCain, Dr. Peck and his family resided in Southern Pines.
