



Trick Shot Artist To Make Southern Pines Home Roost

Chuck Lewis, one of the better known trick shot artists on the golf circuit, will be playing out of Pine Needles Country Club in the future, it was jointly announced last week by Lewis and Warren Bell, co-owner and manager of the club.

Lewis' five-year old daughter, Linda, billed as the world's youngest golf professional, has teamed with her father to make the act one of the most widely sought after in the county. Linda, who once scored 51 for nine holes, has made numerous appearances on television and has been the subject of a number of articles in golf magazines and columns.

Both appeared here during the Golf Carousel and made a big hit with the audience. Lewis, who has a golf bag with an amazing assortment of trick clubs and the gadgets, agreed with Bell at that time to use Pine Needles as home base.

Originally from California, Lewis said this area of the country is the best he has ever seen for golf. "These courses in this area, particularly at this time of year, are far better than those in any other section of the country."

en feet long (he used it to outfit the pro at Pine Needles with his arms tied) and driving tremendous distances with a putter. The

latter trick, he says, anyone can do, although he doesn't advise it. Too many broken putters. Linda has never missed yet in

her favorite trick: hitting a ball from the mouth of a prone spectator. The other professionals play-

ing out of Pine Needles are Betty Dodd and Peggy Kirk Bell, both top players in the women's professional ranks.
