PLANT TOBACCO AND MAKE BIG MONEY.

Since the opening of the Smithfield tobacco market in 1898 success has marked its every step. We have had faith in Smithfield as a leaf tobacco center from the very beginning. Situated in the midst of one of the very best belts of tobacco land in Eastern North Carolina, Smithfield was naturally bound to be a good market, other things being equal. But this was not enough to make our success secure.

The business men of Smithfield seeing the advantages offered have been very liberal with their means in building warehouses, prizeries, etc. But something else was needed to insure success. This need has been met by the clever and energetic tobaccoists who have cast their lots with us and done all they could for the Smithfield market.

Among the leaders in this march toward success we place H. L. Skinner and T. S. Ragsdale. Others who have done much for our success are Will H. Lassiter, C. B. Paylor, J. D. Boyett, E. F. Boyett, A. B. Willingham, R. H. McGuire, O. C. Gregory, W. R. Long and others.

Mr. A. B. Willingham, of the firm of W. A. Willingham & Co., and Mr. O. C. Gregory of the American Tobacco Co., have done much this season to maintain the high prices that have attracted so many people here from far and near. Every man on the market has done his part and has made many friends among the farmers who will continue to stand by the Smithfield market and its obliging tobaccoists.

Some people, even in Johnston county, have got the erroneous idea that Smithfield was not doing much this season as a tobacco market. No greater mistake was ever made. The Smithfield market has been from the beginning of the season one of the best markets in the State. No market in this section has a better record for high prices than our market.

To let the readers of THE HERALD know some of the successful sales here for the past few days and to encourage them to plant some tobacco next year and join the procession, we publish the following:

Mr. J. B. Smith sold a lot of tobacco at the Banner Warehouse this week for \$392.83, the average price being 31 cents per pound.

Mr. Joseph Lee sold a load for \$167.35.

Mr. Will A. Smith sold a lot at the same house and received \$323.38, an average of 32 1/2 cents.

Messrs. Skinner & Ragsdale sold 1,383 pounds for \$313.15.

Among some of those who have made good sales at the Riverside Warehouse we mention the following:

E. S. Rhodes sold 258 pounds for \$113.55.

J. G. Smith received \$127.76 for 861 pounds.

R. A. Whitfield had 649 pounds which brought \$140.97.

For 565 pounds W. J. Price received \$144.04.

H. D. Richardson sold 1,107 for \$291.48.

The following nice prices have been received on the floor of the Farmers Warehouse:

W. B. Johnson sold a lot of nice tobacco for \$155.

Robert Sanders sold one barn for \$195, an average of 25 cents per pound.

Tuesday the break at the Farmers averaged 18 1/2 cents per pound, including scrap.

The above are only a few of the nice prices received on the Smithfield market within the past few days. We could fill several columns with prices that would compare favorably with those already mentioned.

The prices given above prove two things: First that Smithfield is one of the best markets in the State—none better. Second that it pays to raise tobacco and we hope that more of our farmers will try a few acres next year. It will not do to depend on cotton entirely. Our farmers must do something else to endeavor to raise money. Others make money on tobacco. Why not you?
