Laws of N. Carolina, 1828-9. CHAPTER LXV.

An Act to incorporate the Edgecombe Manufacturing Company.

Be it enacted by the General Assembly of the State of North-Carolina, and it is hereby enacted by the authority of the same, That Joel Battle and such other persons as may be associated with him, according to the provisions of the third section of this act, his and their assigns and successors, be, name and style of "the Edgecombe Manufacturing Company," for the purpose of manufacturing cotton, hemp, wool and flax; and by that name and be contracted with; have perpetual succession and a common seal; and hold reconcerns of the company, not inconsistent with the laws of this State.

II. And be it further enacted, That the capital stock of said company shall not be less than thirty thousand dollars, nor more than one hundred thousand stance forbids-on the contrary, every dollars, to be raised by subscription in consideration invites to the attempt to shares of one hundred dollars each, for render ourselves independent of the cawhich books of subscription shall be opened under the direction of Edmund friends. IV. Be it further enacted, That in any election of directors, and all other meetings, each stockholder shall be entitled to one vote for every share held by him, and may vote in person or by ANAWAY from the Subscriber, on proxy, in such manner as may be from time to time prescribed in general mee-
