At the recent conference of the British Royal Sanitary Institute Dr. S. Owens, in an analysis of a London fog, said that to reproduce a dense smoke fog about four milligrams of soot to the cubic meter of air was all that was required. One milligram produced the ordinary winter haze. If a dense smoke extended over the whole of London and up to a height of 400 feet a trifle under 200 tons of soot would be present. The domestic fires of London from six in the morning till nine at night produced over 200 tons of soot, sufficient to produce one of the densest fogs.

Trees Know Winter.
The great buds of the horse-chestnut have a most elaborate arrangement for the winter protection of the delicate parts within, says the American Forestry Magazine. The baby flower cluster is covered by the downy growth of the undeveloped leaves. The latter are surrounded by the tough hard scales, and these are furnished over to keep out the water.
