### Orthopedic Hospital Doing a Great Work

The State Orthopedic Hospital is doing much good at a low cost, according to the last annual report.

There was one patient received at the hospital each day; on an average, and only two were found to show no improvement.

It is rather gratifying to note that the total cost for treatment per day for each patient was \$2.89, which included 562 operations, 1,071 minor treatments, and 461 X-ray treatments. When all this is added to the board, lodging, and any other possible expense, the cost is very low in the term of the great service rendered.
