

FRUIT IS NEEDED IN FOOD SUPPLY

Not Necessary to Have Large Orchard, But Few Trees Desirable

It is not necessary to have an elaborate orchard to secure an adequate supply of fruit for the farm home. A few trees of desirable varieties may be planted about the yard and out-buildings and in addition to serving as shade and ornaments, will give a food source now lacking in many homes.

H. R. Niswonger, extension horticulturist at State College, says it is just as essential in supplying a well-rounded diet for the farm family to have a few fruit trees and vines as it is to have a supply of vegetables from the home garden.

Therefore a good plan is to plant a small number of the different kinds of trees and set them in such a way as to fit in with the planting scheme for beautifying the farm homestead.
