Prominent County Man Dies At Home Near Here Saturday

Funeral Services Held Yesterday For Mr. W. H. Edwards

William H. Edwards, prominent county citizen and a pioneer in the culture of tobacco in this section of Eastern North Carolina, died at his home here last Saturday night at 10 o'clock following a comparatively short period of declining health.

The son of the late John Henry and Pattie G. Edwards, he was born in Vance County 66 years ago. About the close of the last century he moved to this county as one of the pioneers in the culture of tobacco in eastern North Carolina, and his early work proved a foundation for one of this county's foremost crops.

After a short stay in Beaufort County where he supervised the cultivation of tobacco on a large scale, he settled permanently in this county, marrying Miss Annie E. Taylor about 1902.

In his adopted community he was soon recognized as a valuable and upright citizen. During the years he lived, worked and mingled with the and advice were eagerly sought, and people of this section his friendship he gained the admiration of everyone.

The large attendance upon the last rites at the home yesterday morning at 11 o'clock gave silent evidence of the high esteem in which he was held in his adopted community.

Besides his widow, Mr. Edwards is survived by two sons, Messrs. John Henry and William Hewitt Edwards, and one daughter, Miss Ruth Taylor Edwards.

Schools Will Get Cheap Electricity

Meeting in session Monday, the Martin County Board of Education accepted a contract with the Virginia Electric and Power Company carrying a flat rate of 2 cents a kilowatt for light and power used in the schools served by the company's distribution system.

Machinery Set Up For Holding Crop Control Election

Polis Will Be Open From 8 to 5 in Eleven Districts

Machinery for holding the second tobacco-cotton referendum has been set up in this county, the farm agent's office announcing this week that the polls will be open from 8 a. m. to 5 p. m. on Saturday, December 10, in eleven districts.

It is estimated that there are 4,000 eligible to vote in the tobacco referendum and around 1,800 in the cotton election. Last March, Martin County favored the tobacco control program by a vote of 3,740 to 40, and gave the cotton plan a vote of 1,718 to 16.

Any farmer growing tobacco in 1938 whether he be tenant or landlord is entitled to vote for the tobacco program, but there will be no absentee voting or any by proxy.
