whispered that there is a man in the case. No one was present when the shooting took place. There seems to be no friction between their husbands. Mrs. Francis was shot just below the heart and through the thigh, and it is thought that she will likely die. Both women are young and of good families.

## Railroads Lose Tax Suits.

## Freight on Lumber Adjusted.

Washington, Special .- That the freight rate on yellow pine lumber from Arkansas and Texas points should not be higher to Des Moines than to Omaha was decided by the inter-State commerce commission. The greater Des Moines committee had complained against the Chicago Great Western, Missouri Pacific and Wabash and other railroads that 271-2 cents per 100 pounds is unjust as compared with 23 cents from the same territories to Omaha.
