TRAIN SERVICE INADEQUATE

Brevard has, beyond doubt, more to offer the tourist than any resort town in Western North Carolina. Our town possesses all facilities and qualifications necessary to the pleasure and comfort of the vacationist. Our hotel and boarding-house owners have equipped their establishments anew for the season of 1919, our progressive Board of Trade has advertised the attractions of our town to the world and the time has come for the visitors to begin to "arrive". Thirty people from Georgia and Florida, from cities to which a large supply of Brevard literature had been sent, "arrived" at Hendersonville last week enroute to Brevard. When they found that they would have to wait until next morning for a train to Brevard they decided to remain in Hendersonville for the summer. This is only one of several instances of the kind which have occurred within a short period of time. The matter has been taken up with railway officials by Brevard citizens who don't see why arrangements cannot be made by the Brevard Train to make connection at Hendersonville with the trains reaching that place at one and 7:35 P. M. It is pointed out that Brevard has no other connection to make. It simply stands at Hendersonville until about one hour before time for the train from the south to come in, then leaves a long line of chagrined tourists and disappointed citizens to wait several hours for a train. 
