**LEST WE FORGET**

A spirit of unrest pervades the atmosphere from one end of the country to the other. Labor is dissatisfied and capital refuses to be reconciled to changed and changing conditions which this new era has created. But who can expect the "average man" to be on his good behavior with the lawmakers at Washington practically on a strike?

The people of this country will not soon forget the republican clamor last spring, for an extra session of Congress. It was argued that President Wilson should have remained at home—away from the Peace Conference—to get the Sixty-sixth Congress in action. From the first wise democrats asserted that the demand for the assembling of the new Congress came from republican members who wanted the patronage that goes with victory. The old adage that "the horse that pulls the plow should have the fodder" was quoted to that purpose. The republican members practically went "on strike" to accomplish their purpose and President Wilson, in order to protect governmental institutions, met the republican demand for an extra session and it has been "marking time" for the past six months.

It had been so long since the republicans were at the pie counter that they were hungry for it. A casual glance at the record shows that the one task performed to perfection and without delay by the republican leaders was the seizure of the House and Senate jobs. The republicans went further in that direction than ever before. They even hired a number of negroes as elevator conductors in the Capitol, and in the Senate and House office buildings. One negro politician took the place of a wounded soldier boy. A fine record to begin with. Evidently, the propaganda for the extra session is now arising to torment those who forced it. O. K.

Representative Good, republican, of Iowa, is chairman of the House committee on appropriations. In his shouting for an extra session of Congress last spring he said: "A huge task confronts the Congress. The legislative program for reconstruction embraces measures of tremendous importance. Months will be required to enact legislation to unscramble the railroads and provide for their organization on a solid and substantial basis." Will someone kindly point to any signs of an unscrambling of the railroads, or the passage of any measure of "tremendous importance" since the extraordinary session was convened?

The first thing the republican majority in Congress knows the people will begin to demand an investigation of the investigators who are spending the time and money to discover why wars are expensive, while at the same moment one set of republicans in the Senate are opposing the League of Nations and inviting further conflicts.

Perhaps the numerous Congressional "investigations" into the conduct of the war are, after all, only designed to satisfy republican curiosity as to how the democratic administration could achieve so magnificent a success in spite of the G. O. P. in its persistence to oppose anything democratic. "Nothing succeeds like success."

**LITTLE RIVER ITEMS**

The erection of the new school building under the supervision of J. M. Blythe is rapidly being completed. It is something that has been needed for a number of years but until recently did the patrons come together as a unit and say, "Our school must be enlarged in order that our children may have equal opportunities with other children of the county."

When the house is completed and painted and the grounds beautified we will have an ideal place. Our location is so fixed by nature that it can be seen from all directions. The school building is so located until it is the first building to greet in appearance the way-passer as he enters the Little River Valley and the last to bid him adieu as he passes out.

The school has just completed the long needed road running from the public road to the school house.

The school work in general is progressing splendidly; the high school department being under the instruction of J. L. Osteen, the intermediate under Miss A. M. Patton and the primary under Miss B. L. Allen.

The attendance is the best it has ever been in the history of the school. Every one is intinsely interested in making the school the ideal school of the county. The school expects to give a dedication program on the date it is permitted to enter the new building.

On Sunday, Oct. 19th the Junior Order of Brevard presented to the school a Bible and flag. The members of the Lodge attended Sunday School and from the Church they, with the audience marched to the school house and there the customary exercises were carried out. The program consisted of addresses by members of the Lodge, songs, recitations and declamations by the school. After the rendering of the program a sumptuous dinner was spread and all feasted delightfully.

Recently a memorial service was held in behalf of Col. Roosevelt in Little River church. Quite a few were present and a number of short addresses were made.

**GOES UP ON HIGH**

Wealthy Chinese has novel trip from this life to next.

There was a pretty custom among some of the ancients when a prominent citizen died, to send his valet along with him on the road to Paradise, and it was oftentimes necessary to resort to extreme methods to insure this company for the departed. But in the territory of the China-American Trading Company, Ford dealers in Tientsin, China, they have discovered a much better aid to the deceased over the rough places on the trip to the Promised Land.

It is a custom of the Chinese to burn various kinds of effigies at the funeral ceremonies of the rich, the more wealthy the departed the more elaborate the figures burned over his grave. These effigies represent every manner of thing such as human figures, horses, sedan chairs, tables that were loaded with money, etc. The figures usually conform to some of these stereotyped fashions, but at the

funeral of a Mr. Li, who died a short time ago in Tientsin and who was a very wealthy man, the bereaved family outdid themselves and made an imitation of the deceased gentleman's Ford car to be burned at his grave.

This Ford effigy was made entirely of strong Chinese paper stretched on bamboo and reed frames. The car was complete in every detail, the pedals accurately placed and all made of paper and bamboo. The interior of the car was also accurate in detail, being carefully upholstered in paper. The effigy of the driver was a work of art. The car was carried about three miles through crowded streets to the graveside where a match was applied and it was consumed in a few minutes.

This is the first time a motor car has been burned at the grave of a Chinese, and there is every reason to believe that the deceased went up "On High."
