




The chief advantage of a revocable trust is that it allows the person creating it to have effective control of his assets as long as he lives, plus allowing him to make changes in the manner of ultimate distribution, in the same manner as by will. It provides the creator with assurance that his property will be easily available to him, or for his benefit, at times even when he may be physically or mentally incapable of taking care of his own affairs. The trustee of a revocable trust may be given the power in his sole discretion to pay or apply for the benefit of the creator such amounts from the principal of the trust estate, up to the whole of it, as the trustee may, from time to time, deem necessary or advisable for the creator's use and benefit.
