Sunday School Lesson

FOR MARCH 18, 1973 LESSON TEXT: Genesis 3:1-19; Psalm 14:1-3; Jeremiah 20:23; 17:9-10; Romans 1:28 to 2:24

The primary objective of this lesson for today is to stimulate us to actively as we recognize that man has strayed from God, and must seek restoration in repentance. This lesson, indeed, is a deeply personal one for all of us, for the adult and responsible person freely recognizes that sin is an instinct born within each of us, from childhood up.

Recognizing this, he is aware of the battles it entails, and aware also—that that needs help beyond his own powers in dealing with it and its resulting temptations. For, let's face it, the face of sin often wears the mask of desirability—personal gratification, ease, wealth, success, to name but a few! It is only when the mask is removed that the ugliness is discovered—the grief felt by the sinner, and which encompasses, all too often, the innocent parties around him; the guilt with which he must contend daily, throughout his life; the loss of hope, the sense of personal unworthiness that clouds the joy that living should be.

Con. Taylor Opposes Aid To N. Vietnam

U. S. Rep. Roy A. Taylor announced Monday his strong opposition to economic aid to North Vietnam and to the granting of amnesty to those who refused military service. Taylor said, "I cannot support the President's recommendation that Congress appropriate \$2 1/2 billion for economic aid to North Vietnam."

Emphasizing that the war was caused by the aggression of North Vietnam into South Vietnam and that the communists will not be paying South Vietnam for war damages, he stated, "I do not believe that we should pay North Vietnam for such damages."

Taylor stated that following World War II, U. S. financial assistance through the Marshall Plan was designed to strengthen the free countries

so as to prevent communist takeovers. He stressed that, "The Administration proposal today would result in American tax dollars being used to strengthen communism in Southeast Asia. This I cannot support."

Voicing opposition to amnesty for draft dodgers and deserters, Taylor said he believes that "it would not be fair to the servicemen who fought and risked their lives and to those who died or were taken prisoners to grant such pardon to those who deserted their country in time of need."

He suggested that if those "who deserted want to be accepted back into this country, they should return to their military units, take their punishment, and serve out the remainder of their enlistment time."

Attend GOP Meet In Raleigh

F. W. Morgan Jr., and Richard Freeman attended a meeting at the Hilton Inn, Raleigh, where the state GOP launched "Operation Reassessment" which is a program aimed at re-registering North Carolina Democrats as Republicans. Speakers for the confab included State Republican Chairman Frank Rouse, State GOP Vice Chairman, Mrs. Grace J. Rohrer, State Finance Chairman Ted Dent, and Mrs. Mary Alice Warren, President of the North Carolina Federation of Republican Women. Films that demonstrated re-registration techniques were shown.

Allie Ray McCullen, Auditor of Sampson County, has been appointed Executive Secretary of the North Carolina Republican Party. He will be in charge of "Operation Reassessment" in the state. This program is
