**THE ETHEL ENGLISH MOYERS FAMILY**

**GARDENING PRESIDENT** NEW YORK (AP) - Halfway through his term as president, John Quincy Adams discovered that he had plenty of time for gardening.

Mocked by the American people, his dreams shattered by a recalcitrant Congress, Adams awaited an inevitable defeat in 1828.

He turned, as people often do in time of personal tragedy, to gardening.

According to Jack Shepherd, author of "Cannibals of the Heart: A Personal Biography of Louisa and John Quincy Adams," Adams spent two years planting the barren White House grounds.

He got in with his own hands 200 seeds grown from acorns gathered in Washington, shepherd's hickory, persimmon, tulip trees, black and white walnuts, apple, cherry, plum, chestnut, wild rose, red currant, plum, cherry, bayberry, "and some which I do not yet know."
