Cheese, Butter Distribution Set

U.S. Department of Agricultural cheese and butter commodities will be distributed next Wednesday and Thursday at the main office of the Department of Social Services in Marshall.

Last names beginning with A-L will be able to pick up commodities on Wednesday, April 22, between the hours of noon and 4 p.m.

Those with last names beginning with M-Z will be able to pick up commodities on Thursday, April 23, between noon and 4 p.m.

Food Stamp recipients will receive authorization cards from Raleigh as with previous distributions. The cards must be brought to the distribution center to receive commodities. Some income/eligible households were pre-certified in October and

those households will need to bring their blue cards in order to receive commodities.

Households that don't receive food stamps or are not pre-certified will be able to make application the date of distribution that corresponds to the
