LOOKING AFTER AMERICAN SOLDIERS.

More than 600 American women now reading in England, members of the "Care Committee" of the American Red Cross, are regularly visiting wounded American soldiers now in the hospitals in Great Britain. Mrs. Robert Peet Skinner, wife of the American consul-general, is in charge of the headquarters of the committee which has branch organizations in twenty cities in England, Ireland, Scotland and Wales.

The committee is immediately notified of the arrival in any hospital of an American soldier, whether he belongs to the American army or to the British or Canadian forces. More than 5,000 Americans in hospital have received personal calls from the women of the care committee during the last few weeks. The visitors make a special effort to keep the men in touch with their relatives and friends at home. Useful things to wear, delicacies, comforts of various kinds and copies of their home newspapers, are provided by the committee.

THE COLORED AMERICANS.

In commuting the death sentences of 10 of 16 colored soldiers convicted in the courts-martial growing out of the Houston, Tex., riots some time over a year ago, President Wilson says:

"I desire the clemency here ordered to be a recognition of the splendid loyalty of the race to which these soldiers belong and an inspiration to the people of that race to further zeal and service to the country of which they are citizens and for the liberties of which so many of them are now bravely bearing arms at the very front of great fields of battle." It is believed that the action of the President, especially with his reason, will meet with the approval of the American people. The colored Americans as a race have proved their loyalty as soldiers, as workers and as citizens generally. ONE IN EVERY SIX IN NATION BOUGHT THIRD ISSUE BOND

One out of every six persons in the United States bought Liberty Bonds of the Third Loan last April and May. The exact number of subscribers was 18,308,325, or 17.7 per cent of the 103,000,000 estimated population of the country. New York led the volume of subscriptions and number of subscribers, but Delaware subscribed the highest percentage of the assigned quota, and the city of Washington furnished the largest proportion of its population as bond buyers.

This was disclosed today in a Treasury report of Third Loan subscriptions by Federal Reserve districts, States and principal cities. The loan total, \$4,178,516,850, represents an aggregate over-subscription of 138 per cent of the \$3,000,000,000 goal. Every reserve district, every State and nearly every city went above the 100 per cent mark.

In volume of subscriptions the five leading States were: New York, with \$985,000,000, or nearly one fourth of the nation's total; Pennsylvania, \$467,000,000; Illinois, \$279,000,000; Massachusetts, \$228,000,000; and Ohio, \$225,000,000. The leading States in number of bond buyers are: New York, 2,456,000; Pennsylvania, 2,081,000; Illinois, 1,607,000; Massachusetts, 807,000; Ohio, 794,000 and California, 759,000, Washington Dispatch.

WOULD FIX MINIMUM PRICE FOR HOGS AT \$15.50 PER CWT.

Washington, Sept. 25.—Guarantee to farmers of a minimum price of \$15.50 a hundred pounds for hogs during the war is recommended by the national agricultural advisory committee in a report submitted today to the food administration. Though the food administration possesses no power to fix definite prices for hogs or for corn the report points out that prices may be regulated to great extent through controlled orders for the army, navy, allies and export trade.
