Production Of Soft Coal At New Maximum Washington, D. C., Nov. 7.—Soft coal production for the week of October 30 was 122,338,000 tons, a new maximum for the year, figures made public today by the United States Geological Survey show. For four consecutive weeks the daily output has averaged better than 2,000,000 tons, the longest period on record of sustained output at that rate except during the summer of 1918. Anthracite production during the same week was 1,626,000 tons, a decrease of 21,000 tons from the preceding week. This was due, it was said, to observance of the Mitchell Day Holiday, October 29, commemorating the settlement of the great anthracite strike of 1902.
