

NEGRO FARMERS OF HARNETT SHOULD HAVE FARM AGENT

Prof. L. A. Hall, representing the Extension Department of North Carolina was here Monday January 8th, and spoke to a large number of Negro Farmers who were attending the Extension Classes at the Zion Methodist church. He came here from Smithfield, where a new Farm Demonstration agent for Johnston county Negro farmers has begun work.

Feeling that a farm agent would be worth many thousands of dollars to this section, I discussed the matter of securing an agent here for our Negro farmers. He stated that we might be able to get an agent, if we could raise a small sum of money locally. The sum named was \$300.00. I hope that this sum can be raised. Those who are able financially should provide it.

The boll-weevil has created a hard problem for this cotton section, and the farmers need help, instruction, and personal advice. Making money is going to be a different proposition to what it has been when we bought everything we wanted with cotton money. The farmer must have money and unless he is able to make it farming, most of them will quit.

During the next few years our farmers will have their toughest and most perplexing problems to solve. They must adjust their methods to boll weevil conditions. They should be encouraged. Help them by providing the small sum needed to secure the services of county agents for our Negro farmers. This agent can devote all his time visiting, helping and encouraging the Negro farmers to continue their farm operations. The farm agent can reach the farmers because he can make a study of the individual farmer problems.

I sincerely hope every citizen of this section has noted the drift of Negro farmers from South Carolina northward. We all hope this section will not experience such a great loss

of labor and farmers. Yet many of our farmers are puzzled now and can't see how they are to make a living unless they make large yields of cotton. They should have a man to work with them and encourage them. I believe the business and professional men and landlords will provide the \$300.00 needed to supplement the appropriation made by the Extension Department and thus secure the help of a local farm agent for our farmers. Trusting that we may soon have the man to work among our farmers, I remain yours for helping the farmers.
