The extensions of the Carolina ser tice are to include the running of to of the five copper circuits now going to Fort Bragg on to Sanford, ce the Bell system will extend to Greensboro, and the buildof a direct line from Sanford to igh, thus affording this section of the State improved service to con-tral northwestern Carolina. Extenions now under construction or alplated are a new copper treule from Payetteville to Charlotte, which gives direct connection be-tween these cities, without "waystops," and materially reduces the time of service to western Nosth Carolina; three additional copper cis-cuits to Selma affording direct ser-vice to New York, Philadelphia and ther northern cities, two copper lines to Resobero, which with the one now existing will furshin direct connecwith Roseboro, Olinten and Garand, where the Bell system expects eventually to connect up this section firectly with Wilmington.

In addition to these improveme in the toll service, the Carolina company now has a force of diky men at work in thus extending its local ca-bis lines. Sixty thousand dollars is being spent in this work, while the exchange building here will be added to. A new brick building will be built at Dunn, while work has started on e construction of new exchange narters in Washington, N. C.


