The local looping plant of the Durham Hosiery Mills was closed down Friday and the machinery is being shipped to Durham. The plant was discontinued because of poor business in the hosiery line, according to the management. This plant began operation in March 1920, at a time when all manufacturers were overrun with orders. Later in the year the noted slump came on and while the plant has been operated continuously, it has been a losing proposition from the beginning, it is said.

When the small plant was opened here the company had in mind the erection of a large plant in Dunn, but owing to adverse business conditions it was not found advisable to expand the business. However, if this well-known hosiery concern ever finds it to advantage to build additional mills Dunn stands a fair chance of being selected as the location for a mill.

CITIZENS WANT ROAD STRAIGHT

Town Board Agrees To Pay One-Half The Cost Of Straightening

Town Attorney J. C. Clifford was requested by the mayor and town commissioners at their regular semi-monthly meeting last night to advise John Sprunt Hill, district highway commissioner, that it was the desire of the board that the Dunn-Duke hard-surfaced highway connect with West Broad street. A number of property owners went before the board and that matter of which street the highway should connect with and whether or not the road should be straightened at the end of Broad street was discussed.

The consensus of opinion was that the highway should connect with Broad street and that the road should be straightened. The board voted to pay an amount not exceeding \$1,000 towards paying for property and moving the residence of Mrs. J. C. Goodwin, provided the property owners along the highway raise a like amount. The matter was referred to R. M. Warren and B. M. Brewer, members of the street committee of the board, and they will go further into the matter with the interested property owners and citizens.

This matter has been hanging fire for some time, and according to information received from Mr. Hill some definite conclusion must be reached at an early date.

Other business transacted by the board at last night's meeting was of a routine nature.
