As he was being led into the castle, Paul asked the captain to allow him to speak to him. The man said. "Can'st thou speak
to Caesar, and Festus said, "Hast thou appealed unto Cae-sar? unto Caesar shalt thou go." Some days later King Agrippa and his wife, Bernice, came to visit Festus in Caesarca, and Fes-tus told him of Paul's case. Agrippa said, "I would also hear the man myself." So King Agrippa had Paul brought before him, and listened As he was being led into the castle, Paul asked the captain to allow him to speak to him.
