H. E. Buchanan, Commissioner for the 14th Highway Division, has announced that a public hearing will be held in the Jackson County Courthouse Wednesday, August 8, at 2 p.m., to discuss the proposed relocation and reconstruction of U. S. Highway 19A-23 from Sylva to Balsam.

The 1956 Federal Highway Aid Act requires a public hearing to be held for all federal aid projects within or partially within city limits.

Members of the Board of Aldermen, the Jackson County Board of Commissioners and all interested parties are invited to attend this hearing.

Commissioner Buchanan said that the contract for the Sylva to Willets section will be let in Raleigh August 28.

After this meeting is adjourned anyone interested in any road in Jackson County or the 14th Division will be heard.
