Among those assisting with the tea-pouring were Mrs. A. D. P. Heeneey, wife of the Canadian ambassador, and Mrs. William J. Sebald, wife of the deputy assistant secretary of state. Seen welling the chopsticks were Mrs. Sherman Adams, wife of the President's assistant, and Mrs. Harold Burton, wife of the associate justice.

Mrs. Charles Thomas, wife of the navy secretary, was in charge of the bazaar's foreign foods committee and garnered for the sale such items as sardines from Portugal, Christmas cake from Norway, candied fruits from Cuba and chocolate from the Netherlands.

Among the seeds of other bazaars was the annual benefit for the American Friends committee and a foreign exchange student program of the Sidwell Friends School, where many prominent papas and mamas send their youngsters.
