

### Wallace, One of Fifty Towns in State Selected for Air Mail Stop, Oct. 12

Wallace has been selected as one of fifty towns and cities in the State to have the Air Mail service on Oct. 12, according to Mr. J. Johnson, Wallace postmaster. Mr. Johnson is trying to get the mail planes to stop at Wallace as evidenced by a letter from Mayor T. J. Johnson, chairman of the Air Mail campaign in North Carolina, in which he stated that Wallace would be visited by one of the planes on October 12.

The Wallace postmaster feels that Wallace has received a "distinct honor" and hopes that every individual, business house, civic club and other organizations will show appreciation by cooperating in this program and helping to

make it a success. Plans for the observance of air mail week have been worked out by the state committee. On October 12, mail will be picked up by several mail planes in more than fifty towns and cities in every section of the State and rushed to Charlotte and Raleigh where it will be placed upon the regular mail planes of the Eastern Air Lines. The planes will start from Kitty Hawk where aviation was born soon after the turn of the century.

Beautiful cachets are being prepared for each of the cities and towns selected for the one day air mail route. A replica of the Kitty Hawk Memorial will be

on the cachets. From this point they will differ, with each town and city having its own individual cachet, bearing the slogan of the city, some date of important significance or some other material of which the town or city is justly proud.

Wallace will be the only town in Duplin County to have this service, but air mail can be posted at any post office in the county on that date, and these sending it may be sure that it will be sent with prompt dispatch to the first air mail airplane.

### BOND ORDER AUTHORIZING \$56,000 SCHOOL BONDS OF THE COUNTY OF DUPLIN

WHEREAS, the County Board of Education of the County of Duplin, North Carolina has determined that in order that the County, acting as an administrative unit of the public school system of the State, may maintain public schools

in the County for the six months term provided by the Constitution of North Carolina, it is necessary to provide additional school facilities, and

WHEREAS, the Board of Education has determined that it will be necessary to issue \$56,000 of bonds in addition to a grant offered by the Federal Emergency Administration of Public Works in the amount of 45 per cent of the cost of the improvements, together with cash in hand, will be sufficient to construct the necessary improvements, and

WHEREAS, said Board has determined that the funds necessary for the County to raise for the purpose of financing its part of the construction cost are not available, and no provision has been made by local taxation or otherwise by which any of said sum can be provided, other than by the ordinary school tax levied in said County, and that all of said tax is required for other purposes, and said Board has requested the Board of County Commissioners to issue bonds to pay the cost of providing said facilities.

### THEREFORE BE IT RESOLVED:

1. That the Board of County Commissioners of Duplin County, acting as an administrative agency of the State system of public schools, is of the opinion and hereby finds as a fact, that in order to properly maintain the six months' public school term required by the Constitution, it is necessary to construct certain new school buildings, additions and improvements to existing school buildings.

2. That it is hereby found and determined as a fact that during the fiscal year ending June 30, 1937, which was the next preceding fiscal year prior to the passage of this resolution that the said County reduced its outstanding indebtedness by an amount of \$84,050, and that the amount of bonds authorized by this resolution is not in excess of two-thirds of the amount by which said outstanding indebtedness was reduced as aforesaid.

NOW THEREFORE, BE IT ORDERED by the Board of Commissioners of the County of Duplin, North Carolina, as follows:

Section 1. Pursuant to The County Finance Act of North Carolina, as amended, bonds of the County of Duplin, North Carolina,

are hereby authorized to be issued in an aggregate principal amount not exceeding \$56,000, for the purposes hereinafter described.

Section 2. The proceeds of said bonds shall be applied solely to the payment of the cost of construction of new school buildings and additions and improvements to existing school buildings, including necessary equipment therefor.

Section 3. A tax sufficient to pay the principal of and interest on said bonds when due shall be annually levied and collected.

Section 4. A statement of the County debt of Duplin County has been filed with the Clerk of the Board of Commissioners of said County and is open to public inspection.

Section 5. This Order shall take effect thirty days after the first publication thereof, after final passage, unless in the meantime a petition for its submission to the voters is filed under the County Finance Act, in which event it shall take effect when approved by the voters of the County at an election as provided in said Act.

The foregoing Order has been introduced and a sworn statement has been filed under the County Finance Act showing the assessed valuation of the County to be \$15,614,674, and the net debt for school purposes including the proposed bonds, to be \$579,000. A tax will be levied for the payment of the proposed bonds and interest if the same shall be issued. Any citizen or taxpayer may present against the issuance of such bonds at a meeting of the Board of County Commissioners to be held at 10:00 o'clock, A. M., October 18, 1937, or an adjournment thereof.

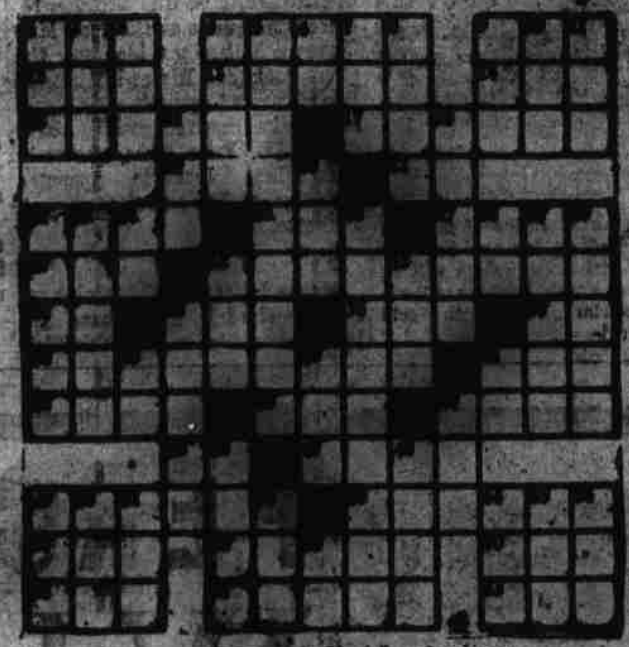
