The next meeting will be at the home of Mrs. Tullie Grimes on June 19.

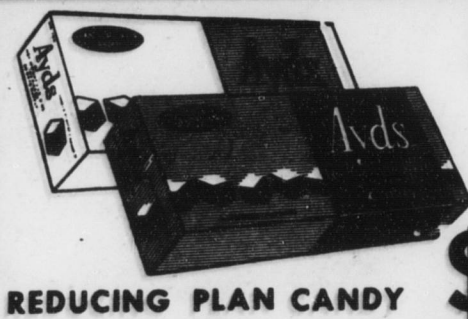

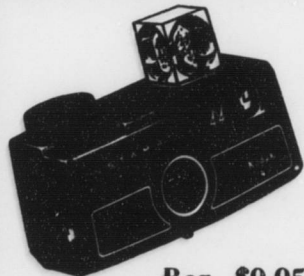
