#### Parents Should **Accompany Small** Children Swimming

They feel that due to the extremely large number of children using the pool this year, it is necessary to enforce this rule as a safety precaution for the children.

Should there be any doubt concerning the age of an unattended small child, the bath house attendant or lifeguard will ask the child to bring a note from their parents.
