them that there will be no discrimination against tobaccos in the Association, and feel confident we will be able to sell a good big per cent of our this year's crop in winter order. In the event we are unable to sell any great quantity in Winter order, we have made arrangements with redrying plants to redry the entire crop, if it is necessary.

We also have our financial arrangements made, which will enable us to make a substantial advance to every grower upon delivery of his tobacco.

This Association has not been organized by intimidation, hate or abuse of any one. The only thing we farmers up here in Kentucky have done is to organize our business on a safe, sane and common sense basis for the purpose of intelligently marketing our tobacco.

We realize that the law of supply and demand will, to a large extent, establish the prices, but under the old system we have finally come to the conclusion that we had absolutely no say as to prices or grades.

We do not expect to ask an exorbitant price for our commodity, but believe we are just as much entitled to a reasonable profit on our efforts as producers as the man who buys it from us.

I understand that you have signed up enough tobacco in Virginia and North Carolina to make your Association possible for the next crop, and at any time we can be any assistance to you, call on us.
