In the agreement, the scheduled wholesale rate increase for April will not be implemented by CP&L if the wholesale buyers do not contest the wholesale rate increase levied last November.

In the original request said Hunt, CP&L filed for a 24%

tive in two phases.

A 13% increase was passed to Lumbee River EMC on November 27, and the remainder was to be passed to Lumbee River EMC on April 27. Cooperative members received a retail rate increase averaging 6% on bills after January 10.

"We don't foresee another rate increase until April 1985," said Hunt. "However, because NCEMC is now serving as our central power agency, any wholesale increase initiated by CP&L, Duke, or VEPCO will affect us."
