Sealed proposals will be received by the County of Hoke, Raeford, North Carolina in the conference room of the Pratt Building, Main Street, Raeford up to 3:00 p.m., Monday, June 18, 1984, and immediately thereafter publicly opened and read for the furnishing of labor, material and equipment entering into the construction of alterations and additions to the Hoke County Courthouse, Raeford, North Carolina.

Bids shall be received as follows: General Construction.
Complete plans, specifications and contract documents will be open for inspection in the office of Dodge and Associates, Architects and Planners, Raleigh, in the offices of the Associated General Contractors, Carolinas Branch Charlotte, Triad and Raleigh, North Carolina, in the local North Carolina offices of F.W. Dodge Corporation, Raleigh, Greensboro and Charlotte, North Carolina and SCAN, Atlanta, Georgia or may be obtained by those qualified and who will make a bid, upon deposit of twenty-five dollars (\$25.00) in cash or certified check. The full deposit will be returned to those submitting a bona fide proposal provided plans and specifications are returned to the architect or engineer in good condition within five days after the date set for receiving bids.

The work will require exterior and interior demolition, repair to existing and new work as follows:
Metal roof, gutters, flashing and drains; exterior masonry; interior plaster; repair and replacement of windows and additional interior glazing.
All contractors are hereby notified that they must have proper license under the State laws governing their respective trades.
General Contractors are notified that Chapter 87, Article 1, General Statutes of North Carolina, will be observed in receiving and awarding general contracts.

Each proposal shall be accompanied by a cash deposit or a certified check drawn on some bank or trust company insured by the Federal Deposit Insurance Corporation, of an amount equal to not less than 5 percent of the proposal or in lieu thereof a bidder may offer a bid bond of 5 percent of the bid executed by a surety company licensed under the laws of North Carolina to execute such bonds, conditioned that the surety will upon demand forthwith make payment to the obligee upon said bond if the bidder fails to execute the contract in accordance with the bid bond, and upon failure to forthwith make payment, the surety shall pay to the obligee an amount equal to double the amount of said bond.

Said deposit shall be retained by the Owner as liquidated damages in event of failure of the successful bidder to execute the contract within ten days after the award or to give satisfactory surety as required by law.
Performance and Payment Bond will be required for one hundred percent (100%) of the contract price.
Payment will be made on the basis of ninety percent (90%) of monthly estimates and final payment made upon completion and acceptance of work.
