Dog catcher nabbed for AWOL charge

Last Tuesday, the new Raeford City Dog Warden, who was also a part-time city police dispatcher, was taken into custody for being absent without leave (AWOL) from the Army.

George Wesley Johnson, who was a resident of the Harmony Heights mobile home subdivision, was turned over to military policemen last Wednesday morn-ing, said Raeford Police Chief Leonard Wiggins.

Questions about the man began to arise late the week before his arrest when his license plate number was run through the Police Infor-

The man had apparently borrowed a car from a fellow employee at Raeford City Hall to drive to his hometown of Brooksville, Florida.

(Continued from page 1A) from the sale of the old armory, said Balfour.

When asked if the building would be an asset to the county for industrial recruitment purposes, Raeford-Hoke Economic Development Director John Howard said; 'One of the shortfalls of selling this county is the availability of buildings.

Howard said that there is only one building currently available in the county for housing a manufac-turing operation. That building is an abandoned school in Rockfish where another industry recently moved from.

That industry built an addition to the school suitable for manufac-

According to Howard, when that building is sold, there will be nowhere else to house industry.

"I would rather have the old armory for sale than not," Howard.

After much discussion, commissioners passed a motion allowing Department of Social (DSS) Director Ken Witherspoon and Cowan to apply for a \$56,000 grant that can be used to build a senior citizen center in Hoke County.

The state money is being offered to counties like Hoke who have no centers, Witherspoon said.

The grant will require "in-kind" or cash matching funds of \$6,270,

said the DSS director. Former county commissioner Mable Riley, on hand for the

meeting, said that she has had contact with a great many senior citizens in the county and that they would favor the building of a

Commissioners appeared to have problems with the grant as it would put the county under tertain

obligations.
"It really bothers me to accept something in a hurry up deal with strings attached," said Commis-

sioner Upchurch.
Upchurch was speaking specifically to the lack of organization, no plans for the money and

no site for the center.

Balfour also questioned the same things.

Witherspoon and Cowan will report to the board during their next meeting.
