## Hitch-Hiking in Flood Wasn't So Good



Washington, August 12-The presidential campaign machinery of both the major parties has now been set up and the actual campaign is about to begin. The selection by the President of Edward J. Flynn, of New York, as Chairman of the Democratic National Committee to succeed Postmaster-General Farley, while not expected, is considered by Democratic politicians generally as a good choice.

Mr. Roosevelt wanted Senator Byrnes of South Carolina to take the post. Mr. Byrnes is regarded as the smartest political strate-gist in his party. He declined the Presidential invitation on the plea that he is a victim of hay fever which always lays him low for a month or more at the very time of year when the campaign will be at its height.

Chairman Flynn inherits from Chairman Farley a thoroughly organized party machine. He has not the intimate knowledge of party leaders and workers throughout the nation that Mr Farley has. 
