ORDINANCE,

Be it ordained by the Board of Aldermen of the Town of Hazelwool,

North Carolina: Section 1. That the negotiable coupon bonds of the Town of Hazelwood, North Carolina, he issued in the maximum principal amount of \$10,000 to be known as Water Bonds for the purpose of extending the water system in and for the said

Section 2. That a tax sufficient to pay the principal of the said bonds and the interest thereon, shall be annually levied and collected.

Section 3. That a Statement of Indebtedness of the said municipality has been filed with the Clerk pursuant to the Municipal Finance Act and is open to public inspection.

Section 4. That this Ordinance take effect thirty days after its first puelleation, unless in the meantime a pitition for its submission to the voters is filed under the Municipal Finance Act, and that in such event, it shall take effect when approved by the voters of the Municipality at an election as provided in said Act,

The foregoing Ordinance was pased on the 27th day of April, 1925 and was first published on the 30th day of April, 1925. Any action of proceeding questioning the validity of said Ordinance must be commenced within thirty days after its airst publication
