

The 1967 General Assembly of North Carolina enacted legislation granting the State Board of Health the authority to promulgate rules and regulations governing ambulance service within the State. The State Board of Health, acting under the authority and direction of this 1967 legislation, met on October 12, 1967 and adopted rules and regulations governing ambulance services. These rules and regulations, so adopted by the State Board of Health, will go into effect on January 10, 1968. Under these new rules and regulations, many additional restrictions and requirements are placed upon those who may legally provide ambulance service. These additional restrictions and requirements make it impossible for funeral directors to provide ambulance service on a limited basis as in the past. Therefore, the undersigned funeral directors will not be able to apply for Ambulance Service Operation Permits required under the new rules and regulations of the State Board of Health and therefore find it necessary to cease to provide ambulance service as of the 10th. day of January, 1968.
