## Legal Notice

**NORTH CAROLINA DUPLIN COUNTY TOWN OF KENANSVILLE ORDINANCE RELATING TO MOTOR VEHICLE REGISTRATION AND TOWN LICENSE PLATES**

BE IT ORDAINED by the Board of Commissioners of the Town of Kenansville, North Carolina: **SECTION 1: MOTOR VEHICLES REQUIRED TO BE REGISTERED, PERIOD OF REGISTRATION AND FEE.** Every resident motor vehicle operated in the Town, except motor vehicles operated for car display or car exhibition purposes by car manufacturers or dealers, displaying dealers' license plates issued by the State of North Carolina shall be registered with the Town Tax Collector. The period of registration shall include the twelve (12) months, between January 1st and December 31st of the year of registration. The fee for registration shall be Two (\$2.00) Dollars or One (\$1.00) Dollar after expiration of six months of taxable year. **SECTION 2: WAIVER FOR FIREMEN AND EMERGENCY MEDICAL TEAMS.** It is hereby provided that the annual license tax imposed under this Ordinance is waived for individuals serving as firemen or as members of emergency medical teams. No more than one motor vehicle owned by each member to be exempt. **SECTION 3: TAX COLLECTOR TO ISSUE NUMBER PLATES.** For every registered motor vehicle the Tax Collector shall issue to the person registering the vehicle, an appropriate number plate or sticker. **SECTION 4: WHEN AND HOW NUMBER PLATES TRANSFERABLE.** A number plate or sticker shall not be transferred from one individual to another and it shall not be used by any person upon any motor vehicle except upon one for which it was issued, provided,

**SECTION 5: PENALTY FOR FAILURE TO PURCHASE TOWN NUMBER PLATE OR STICKER.** The owner of any vehicle subject to registration as required in Section 1 that fails to register a vehicle by the 15th day of February of each year shall pay to the tax collector the sum of \$5.00 as a civil penalty in lieu of a criminal prosecution.

**SECTION 6:** All other laws, ordinances or regulations heretofore passed by the governing body which are repugnant to this ordinance are hereby repealed. **SECTION 7: EFFECTIVE DATE.** This ordinance shall be in full force and effect from the tenth day of January, 1983.
