Bids To Relocate Beach Water Line Accepted

Brunswick County commissioners accepted a bid of \$17,736 Monday night for relocation of a water line threatened by erosion on the east end of Holden Beach.

The bid, submitted by Sneed Inc. of Wilmington, reflects labor costs only. It was the lowest of the six bids submitted.

Under a plan approved last spring, the town of Holden Beach is providing about 1,400 feet of 12-inch diameter piping and rights-of-way for the project. Approximately two blocks of water line will be moved. The county will provide labor, including two large-diameter taps.

County and Holden Beach commissioners cooperated in the venture because while the line is owned by Holden Beach it is vital to the present county water system. County Engineer Daniel Shields told the current commissioners. The line across Lockwood Folly Inlet, he reminded them, is the weakest link and will pose a threat until the new line down U.S. 17 is completed. Then, if a break occurs, pumping station No. 3 can be reversed to back pump to towns that lose service.

Presently, if the line breaks it would interrupt county service to all points south—including Shallotte, Ocean Isle and Sunset Beach.

Sunset Slates Second Hearing On Land Use

A second public hearing on the revision of the Sunset Beach land use plan has been scheduled for April 30 at 7:30 p.m. at the town hall.

Town council set the hearing at its regular monthly meeting Monday night. A similar hearing was conducted last Tuesday.

A random sample of the town's property owners have been surveyed in conjunction with the revision of the land use plan, which is required by the Coastal Area Management Act every five years.

Town Manager Wallace Martin has said the purpose of the hearings is to address land use planning problems citizens have encountered.
