Deputies Answer 722 Calls

Brunswick County sheriff's deputies answered 722 calls and made 411 investigations during May, according to the monthly report of Sheriff John Carr Davis.
Officers made 29 arrests as prosecuting witness and summoned 48 witnesses, while patrol cars logged 69,756 miles and used 4,192 gallons of fuel and ten quarts of oil.
Five juvenile petitions were drawn and served along with 598 civil papers and 67 local and 174 foreign warrants, Davis reported. Four mental and inebriate papers were also served.
Deputies spent 121 hours in court on duty, 25 hours off duty and 320 hours in court as duty officer. Property recovered by the department totaled \$53,337.25.
Fifteen crime prevention meetings were held in May, when officers made 24 trips out of the county.

Robinson To Direct Aging Office

Ronnie Robinson of Route 2, Supply, began work Tuesday as director of the county's new older adults department.
The office on aging was created by the Brunswick County Board of Commissioners after problems in coordination of services to the county's rapidly increasing senior citizen population were identified earlier this year. Several existing programs will be consolidated in the new office. Commissioners are expecting improved services at no anticipated increase in cost to the county.
A \$70,000 budget is proposed for the office during 1985-86.
Robinson, 33, was briefly a candidate for the office of Brunswick County Register of Deeds in 1984, withdrawing from the Democratic ticket before the primary. He was a salesman for Brunswick Water Purification and was previously employed by the Internal Revenue Service, the General Accounting Office and the Sunny Point Military Ocean Terminal.

He will report directly to the county commissioners and will not be covered by the county's personnel policy.
As older adults director, he will work with county residents age 60 and older, serving as an advocate and helping match them with services for which they qualify, working with seniors who do volunteer work and with those who volunteer to work with senior citizens.
He is temporarily working out of the conference room of the administration building at the Brunswick County Government Center at Bolivia.
When introduced to county commissioners Monday night, Robinson said he planned to run the office "strictly by the rules" set out by state and federal funding sources.
"I will try to make this the best department out here," he said. "It's important to reach some senior citizens who don't know what services are available."
