Ex-Deputy Charged In Armed Robbery Monday

A former Brunswick County sheriff's deputy was arrested Monday morning and charged with the armed robbery of a Wilmington supermarket.

Gilbert Wayne Harrington of 4014 Cherry Ave., Southport, was charged by the Wilmington Police Department with armed robbery and larceny after a supermarket on Oleander Drive was robbed.

Wilmington police reported a man

entered the store Monday morning with a .45 caliber revolver and told the manager and head cashier to go to the office and hand over the store's money.

The manager placed an undisclosed amount of money in a bag and the robber left the store. Both Wilmington police and the New Hanover County Sheriff's Department were called to the scene.

Harrington was later arrested at

his Southport home and is being held in the New Hanover County Jail under \$50,000 bond.

According to Brunswick County Sheriff John Carr Davis, Harrington was hired by the department on Jan. 5, 1979 and worked until Feb. 28, 1983, when he was fired.

"When he couldn't pay his bills, I had to terminate him," Davis said. "He was a good officer. Everyone liked him."
