Shallotte Chief Wants Drivers To Pay More Attention To Road

Shallotte police officers may start writing more citations following auto accidents to encourage motorists to be more alert, the town's new police

"I think what we're going to do is start filing more charges in accident cases," Chief Don Stovall said Tuesday. "That may make a few people mad. But maybe it will make people think a little bit more when they're

Drivers allowing their attention to wander away from the road appears to contribute to the high accident rate, he suggested, based on observations during his first month on the job and discussions with other officers.

Accidents are frequent, but minor in nature within this town of about 700 residents. Most occur along U.S. 17, a report filed by Lt. Rodney Gause.

Judgment Sought In Meares Suit

Four government defendants in an action filed by a former Brunswick County employee want a federal judge to rule on the case, saying there is "no disputed issue of material fact."

The complaint was filed Sept. 10 by Alinda Meares, former administrative secretary with the Brunswick County Department of Social Services who was fired in September 1981 by former DSS director Jamie Orrock.

Requesting a jury trial, she seeks rather than the usual 30 days. compensation plus reinstatement and back pay from the five defendants: the county, the department of social services and their respective governing boards, and Orrock.

Attorneys for the four government defendants filed a motion for summary judgement in U.S. District Court in Wilmington on July 17. On July 25, U.S. Magistrate J. Rich Leonard ruled that Ms. Meares has until Oct. 1 to respond to the motion

According to the brief supporting the motion for summary judgement, Mrs. Meares has not alleged she was fired pursuant to a custom or policy of the governmental entities or that a policy or custom of those entities denied her due process or any other constititional right.

These allegations would provide the only basis for her complaint, the defendants argue.

The brief says that rather, Ms. Meares alleged that Orrock was an agent of the governmental entitities when he dismissed her. But it continues, depositions indicate that is not the case. Also, Ms. Meares alleged she had been denied due process

by not having an opportunity to present her grievance in a binding hear-

Ms. Meares dropped grievance appeals begun through both the State Personnel Commission and through the state courts. She later entered into a settlement with the social services board that was approved by the State Personnel Commission. It provided for her full reinstatement with back pay and benefits. But in Wake County Superior Court, Judge Pou Bailey recently ruled that the social services board was without the authority to enter such a binding agreement with an employee. remanding the matter to the Commission.
