Ocean Isle Beach policemen raided a mobile home in Lakewood Estates after following a truck there from a house they had been watching at Ocean Isle Beach. They found more than 14,000 pounds of marijuana inside. Five men were arrested; at least one has pleaded guilty to state charges, Christopher Glen Ford.
