

Man Convicted Of Employment Security Fraud

A man who repeatedly received unemployment benefits to which he was not entitled was convicted Wednesday, Oct. 30, in Brunswick County District Court.

Charged on eight counts, Johnnie Bryant Jr. pleaded guilty to employment security fraud. He was sentenced by Judge Lee J. Greer Jr. to the State Department of Corrections two years, suspended for three years with three years of supervised probation on condition he pay a \$200 fine, make restitution of \$510 to the Employment Security Commission and not make application for employment benefits. A second, identical sentence goes into effect at the expiration of the first.

Bryant collected unemployment checks over a period of more than 10 weeks while he was employed at first one business and then another.

Joining Greer in hearing cases in Brunswick County District Criminal Court the week of Oct. 28-31 was Judge Jerry A. Jolly on Oct. 31.

Billy Sullivan, contributing to delinquency; State Department of Corrections not less nor more than two years, suspended three years, supervised probation three years, \$100 and costs, not associate with K. Oxendine without expressed written permission of guardian or legal custodian.

Dana Teeters, misdemeanor larceny; State Department of Corrections Committed Youthful Offender not less nor more than two

years, suspended two years, supervised probation two years, \$100 and costs, restitution attorney fees \$200, Southeastern Mental Health counseling, complete course, remain full-time employed or enroll as a student in public school or technical school.

William E. Thompson, worthless check \$10.75; county jail 30 days, suspended two years, restitution and costs.

Ted Walker, larceny (judgement); State Department of Corrections not less nor more than two years, with permission of the defendant suspended two years, supervised probation two years, \$100 and costs, attorney fees \$200, restitution Jeffrey Brewer \$1,042.23.

Jack McKee Jr., assault on a female; county jail 60 days, suspended two years, \$25 and costs, not go about or communicate with plaintiff without written permission.

Jerry Maggard, intoxicated and disruptive; county jail 30 days, suspended two years, costs, not go about Brunswick County Sheriff's Department except for official business, counseling at Southeastern Mental Health.

Sherman Smith, assault on a female; county jail not less nor more than six months, suspended three years, unsupervised probation three years, \$25 and costs, not go about plaintiff or marital home without expressed written permission of plaintiff, Southeastern Mental Health counseling, follow course.
