Leland Man Convicted On Gambling, ABC Violations

A Leland man was convicted May 13 in Brunswick County District Criminal Court on several charges relating to his operation of a nightspot, the Club Valentino, in Leland.

Hardy Ballard, 59, of Route 1, Leland, pleaded guilty and was found guilty of one count each of allowing gambling, possession of spiritous liquor where unauthorized and possession of spiritous liquor without a permit.

Judge D. Jack Hooks Jr. sentenced Ballard to two years on the Brunswick County Jail/State Department of Corrections, suspended two years with two years of supervised probation, and fined him \$1,000 and costs. He is not to possess liquor or alcoholic beverages where prohibited, not to allow persons to sell liquor in any establishment operated by him that does not have the appropriate permits, and is not to allow gambling

Ballard is appealing the judgment. Other cases heard May 11-13 by Hooks were resolved as follows:
