Long Beach Man Gets Suspended Sentence For Area Break-Ins

A Long Beach man was placed on probation last week after he admitted breaking into two businesses and a county school and stealing \$12,255 worth of goods.

Brian Patrick Smyla, 20, of 6th Street, pleaded guilty to three counts of misdemeanor breaking, entering and larceny on Jan. 17 in Brunswick County District Criminal Court, according to the clerk of court's office.

Judge D. Jack Hooks Jr. sentenced Smyla to two consecutive two-year prison terms and suspended the sentence for three years, with three years of supervised probation. One of the terms was for the three breakins; the other, for the three larcenies.

Court records show Smyla was arrested June 17, 1987, by the Brunswick County Sheriff's Department in connection with break-ins at occurred on April 28, 1987, at a sales and repair service office owned by Avery Formyduval on U.S. 17, Shallotte; on May 1, 1987, at a mobile home sales office owned by Jerry Nellenback on U.S. 17, Supply; and on May 10, 1987, at North Brunswick High School, Leland.

The defendant stole \$5,270 in electronic equipment from the Shallotte business; a boat motor, typewriter, calculator and three blank checks. together worth \$375, from the Supply
