

Twelve Sentenced On DWI Charges In Brunswick District Court

Twelve persons were sentenced on driving while impaired charges in Brunswick County District Court last week as three different judges conducted the three-day session.

Judge Jerry A. Jolly sentenced five DWI defendants, giving three active terms ranging from two days to 14 days in jail. One was also placed under 10 days of house arrest.

Judge D. Jack Hooks Jr. sentenced two DWI defendants, one to 48 hours of community service and another to 72 hours of community service. Both were fined \$100.

Judge Napoleon B. Barefoot Jr. sentenced five on DWI charges. One defendant received a one-year prison term and was recommended for the DART program, a drug and alcohol rehabilitation treatment program offered by the N.C. Department of Corrections.
