Calabash Man Gets One-Year Sentence For Marijuana Charges

sentenced to a year in prison last week after pleading guilty in Brunswick County District Court to charges of possessing marijuana and drug paraphera aria.

Michael Kevin Hughes of Hidden Valley Road was charged with having in his possession less than 1.5 ounces of marijuana and "several plastic bags and a box used to package and repackage a controlled substance," according to the arrest warrants. The offense occurred Feb. 17.

Judge Napoleon B. Barefoot Jr. sentenced Hughes to one year in prison "to run at the expiration of any sentence he is now serving.

Barefoot presided over district court Wednesday and Thursday (April 7 and 8), while Judge David Wall heard cases Tuesday. Assistant district attorneys Ola Lewis and Marion Warren presented evidence
