

Man With Lengthy Arrest Record Gets Three Jail Sentences

A man who has been charged with more than 50 past offenses was sentenced to three years behind bars last week after pleading guilty in Brunswick County District Court to charges of assaulting a police officer, breaking a car windshield, fighting with a knife and threatening to kill someone.

Daniel Wayne Briles, 26, of Dale Drive, Ocean Isle Beach, also known as "Pedro," pleaded guilty May 4 to one charge each of assault on a government official, communicating threats, aggravated affray and injury to personal property, court records show.

Briles was charged with striking Sgt. Lisa Massey of the Sunset Beach Police Department while she was investigating a disturbance call March 27. Three days later he was accused of getting into a fight "to the terror and disturbance of other citizens," during which he tried to stab another man with a knife.

Court records indicate that Briles has been charged in the past with six counts of resisting a public officer, three counts of assault on a female, five counts of breaking and entering, four counts of being intoxicated and disruptive, three counts of larceny and numerous other offenses including assault with a deadly weapon.

In a June district court session, Briles admitted threatening to kill an Ocean Isle Beach man on May 15, 1992, by showing his sister a gun and "telling her to tell her brother that he was going to blow his (expletive deleted) brains out." Sentencing had been delayed in that case on the condition that he stay away from the brother and sister.

The district attorney last week asked the judge to sentence Briles in that case because of another incident that was alleged to have occurred March 27.

According to court documents, Briles approached the sister while she was sitting in her car at a Seaside convenience store and broke the windshield. Three days later he allegedly followed her as she was leaving a Seaside grocery store "and attempted to chase her as she got into her car to leave."

Judge Napoleon Barefoot Jr. gave Briles three consecutive sentences, including six months in the Brunswick County Jail, followed by two years in the N.C. Department of Corrections, followed by another six months in Brunswick County Jail.

Other defendants who appeared in court last week, with their charges, pleas and sentences include:
