

Bolivia Auto Mechanic Pleads Guilty To Illegal Liquor Sales

A Bolivia man charged with a total of 24 misdemeanors involving the possession and sale of non-tax-paid liquor pleaded guilty to four charges in Brunswick County District Court last week and was given a pair of two-year suspended jail sentences.

James Adolph Williams, 51, of Albright Road, entered a negotiated plea of guilty to two counts of possessing and two counts of selling illegal liquor, according to court records. The other 20 charges were dismissed as part of the plea bargain.

Williams was arrested last December as part of a joint undercover operation by the Brunswick County Sheriff's Department Alcoholic Beverages Control enforcement division and the N.C. Alcohol Law Enforcement agency.

Informants made several purchases of up to four gallons of illegal liquor at the Adolph's Transmission Service garage Williams operates in Bolivia, court records show.

In a raid on the garage last Dec. 31, agents seized several bottles partially filled with illegal liquor, other bottles containing mixed alcoholic beverages and seven cans of beer.

According to Brunswick ABC enforcement officer Mike Speck, the sheriff's department had "received several complaints of the continuing illegal sale of alcoholic beverages" at Williams' place of business during the 12 months prior to his arrest.

In addition to his suspended jail sentences, Williams was ordered to pay \$122 restitution to the Brunswick County Sheriff's Department and \$206 court costs. He is not to possess alcohol for the purpose of sale and must submit to warrantless searches. He was put on supervised probation for three years.

District Court Judge David Wall presided over court Tuesday, while Judge Ola Lewis heard cases Monday. Attorney Rick Green prosecuted.
