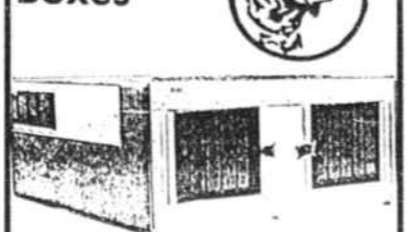

The Brunswick County Board of Commissioners will hold a public hearing on September 7, 1993 at 6:00 PM. in the Commissioners Chambers, Administration Building, Brunswick County Government Center, Bolivia, North Carolina, to receive comment on the following proposed amendments to the Brunswick County Zoning Ordinance and Partial Development Code:

SECTION A

Article 4, Schedule of District Regulations, Part A, Traditional Zoning Districts, Section 4.104 C—LD, Commercial Low Density Zoning District, Sub-Section B. Permitted Principal Uses and Structures:

Item 6. Strike all language after the word "establishments" so that this item reads "Eating and drinking establishments."

Item 16. Strike all language after the opening words "Filling station" and add that following language "or fuel dispensing pumps, which uses can be combined in one structure with other permitted or permissible uses or which dispensing pumps can be accessory to other permitted or permissible uses and structures".

Add an item 20. One dwelling unit on an existing lot as of the effective date of this ordinance if the lot is less than ten thousand (10,000) square feet in area and/or less than one hundred feet (100') in width.

SECTION B

Article V, Development Standards, Section 1. Off-Street Parking and Loading Space:

Section 5.104. Design Standards. Delete first paragraph and substitute the following two paragraphs:

"Paving of parking and loading spaces is not required as long as soil stabilization is provided to assure ruts and pot holes will not occur, and that there will be minimal dust created by driving and maneuvering.

For a parking lot requiring twenty (20) or more parking spaces, there is to be a shrubbery bed at least four feet in height and five feet in width, provided that all exterior property lines excepting along street frontage, to filter storm waters and to be a visual buffer."

Section 5.106, Number of Spaces Required. Under the last listed item, "Manufacturing Establishments", add "Warehouses and Storage Facilities".

SECTION C

Article 6. Supplementary Regulations. Section 6.101. Application:

At the end of the sentence in D., delete period, add comma, and then add "or as stipulated under Permitted or Accessory Uses and Structures in the various Zoning Districts.

SECTION D

1. On zoning map sheets 213 and 229, for all land parcels created by division for the James Henderson Johnson Heirs, including tax parcel identified by number 213000064, 21300006404, 21300006405, 21300006406, 21300006407, 21300006408, 21300006409, 21300006410, 21300006411, 21300006412, 21300006413, 21300006501, 229000 85, 229000086, 229000087, 229000088, and 229000089, all from H-M, Heavy Manufacturing Zoning District, to RU, Rural Zoning District.
