## Leland Man Gets Five Years On Misdemeanor Charges

sentenced to five years in prison last week after pleading guilty in Brunswick County District Court to seven misdemeanor charges including breaking and entering, larceny and possession of stolen goods.

Mark Timothy Phelps of Natures Mobile Home Park had been charged with one count of felonious breaking and entering, two counts of felonious larceny, two counts of misdemeanor larceny and one charge each of second degree trespassing and possession of stolen goods.

Phelps was given consecutive sentences of two years, two years and one year as part of a plea bargaining arrangement in which the state agreed to reduce the felony charges to misdemeanors and to consolidate the cases for judgment.

In accepting the arrangement, Judge Ola Lewis ordered Phelps to pay \$731 restitution and \$300 for his court-appointed lawyer Mark Lewis.

Phelps will serve his sentence as a committed youthful offender with credit for the 23 days he spent in jail awaiting trial.

Judge Lewis presided over district court Monday and Tuesday, while Judge Napoleon Barefoot heard cases Wednesday. Assistant District Attorney Rick Green prosecuted cases for the state.
