Man Charged With Burglary Of Wife's Home In Supply

A 26-year-old Sanford man was arrested on a firstdegree burglary charge after he allegedly broke into the home of his estranged wife, threatened to kill her and left with more than \$550 worth of her cash and property, a Brunswick County sheriff's detective said Monday.

According to a crime report on file at the sheriff's office, the victim told Detective Tom Hunter that her husband broke into her home on Spruce Street in the Ocean Pines subdivision at about 8:45 Sunday night.

The victim told Hunter that Brian Thomas Rose Jr. forced his way into the residence and threatened her by saying "I'm going to kill you," and "I'm going to beat you to death.

She said she ran to a neighbor's house to call 911 for assistance. When she returned she found Rose gone along with her wallet, a stereo tape player and a videocassette recorder.

Rose was arrested Monday afternoon, Hunter said. In other crime reports:

Deputy Keithan Horne arrested a 22-year-old Longwood man on a charge of felonious larceny less than 14 hours after the theft of an outboard motor was reported Wednesday morning. The victim said he left his

boat tied up at the Holden Seafood dock at Shallotte Point Tuesday and returned the next morning to find his 35-horsepower Johnson outboard missing. Later that day. Horne was advised by Deputy R. Long that he had stopped a pickup truck with a Johnson outboard in the back. At about 10 p.m., Horne spotted the suspect's truck on #5 Schoolhouse Road. The suspect said he sold the motor to a man in Seaside for \$100. It was recovered and returned to its owner.

A 27-year-old Southport man who was being booked at the Brunswick County Jail was charged with the felonious theft of evidence after he allegedly stole the records of his arrest and took them home. Recovered at the man's residence at the Boardwalk Mobile Home Park were two citations, two breathalyzer cards, a 10day driver's license revocation order and an officer's affidavit form, according to Deputy Johnny Earp's report.

Someone set fire to a 1993 Nissan Sentra parked on Maco Road in Leland recently. The owner told Deputy William Hewett that his wife's car was left there after it broke down. He said the vehicle was set afire on the night of Dec. 30. It appeared that the car's battery had been stolen. The man "stated that he did not give anyone consent to remove any of the property from the vehicle or any consent to burn the vehicle," the report said. The car was a total loss, valued at \$12,500.

Wilmington Woman Stabbed To Death In Belville Park

A renewed relationship with a former boyfriend ended in a savage murder early Saturday morning when a 33-year-old Wilmington woman was slashed and stabbed repeatedly in a Belville park, allegedly by a Leland man arrested less than

10 hours later. When Bertha Mae Patterson left

her home in the Jervey housing project Fighth. night, she said she was going out with Nolan Anthony Dukes, 26, of Village 1227 Road. with

whom she had a relationship last year, according to Detective Capt. Phil Perry of the Brunswick County Sheriff's De-

"It appears they went out on a date somewhere in the Leland area and during the course of the evening they apparently got into some sort of Perry said. argument," "Evidently, from there, things went progressively downhill."

At about 8:27 a.m., N.C. Wildlife Officer Brian Loflin was driving past the future site of Belville's John D. Long Memorial Park when he

spotted what looked like a body lying face up in a clearing. The park is located on N.C. 133, about a mile and a half from Main Street.

Patterson's body was found fully clothed in a blood-soaked blouse and jogging pants. Several puddles of blood marked the surrounding dirt. There were deep slashes on both sides of her face and numerous stab wounds on her upper torso.

There were also cuts on her hand id arms, probably received as she tried to fight off her attacker, Perry said. The body was sent to Jacksonville for an autopsy.

Investigators believe Patterson was driven to the scene and murdered outside the vehicle sometime after midnight. The area, which is soon to be dedicated as a public park and boat ramp, is already popular as a late-night gathering spot.

Acting on evidence found at the crime scene, sheriff's detectives and State Bureau of Investigation agents questioned Dukes at his home later that day. He was arrested and charged with murder Saturday night.

Detectives impounded Dukes' white 1983 Subaru station wagon as evidence. Also in police custody is a 6-to-8-inch sheath knife, believed to be the murder weapon.

At a first appearance in Bruns-

Shallotte lawyer James Payne was appointed to represent Dukes. He told the court he was employed by two Wilmington temporary services companies and had a monthly income of \$200.

A probable cause hearing was scheduled for Jan. 18. Dukes is being held in Brunswick County Jail

Patterson's murder is the first in Brunswick County during 1994.


